Answer: No, the entity is expected to have reduced cash outlays for the near term:

- All planned drilling programs have been completed
- Field activities are now focussed on low cost mapping, and rock chip sampling and a complimentary IP geophysical survey (as part of a test for potential further IP surveys)
- There has been a reduction of employees through the non-renewal of contracts for contract employees.
- Non-essential expenditures have been or will not be renewed when contracts terminate

8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The entity is in the process of completing a capital raise program via a share placement and a Share Purchase Plan (SPP). Tranche 1 of the Placement, comprising 86,401,227 Placement Shares (~\$0.86M) was completed in the quarter. Tranche 2 of the Placement (~\$1.14M), will be issued subject to shareholder approval at an extraordinary general meeting being held on 14 February 2024. In addition a SPP seeking to raise \$0.5M is underway as at the date of this report.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. The entity holds mineral project interests that have been well supported by investors in the broader market. As a result, the entity remains confident that it will be able to continue to meet its business objectives.
